*An Act to abolish the Calcutta and Suburban Police Superannuation Fund.*

WHEREAS it is expedient to abolish the Calcutta and Suburban Police Superannuation Fund ;

Short title,

It is hereby enacted as follows:—

1. This Act may be called the Calcutta and Suburban Police (Superannuation Fund) Act, 1905.

2. [Repeal of enactments.]—Rep. by s.3 and the Second Sch. of the Bengal Repealing and Amending Act, 1938 (Ben. Act I of 1939).

3. All sums standing to the credit of the Calcutta and Suburban Police Superannuation Fund shall vest in <sup>2</sup>[the State Government], to be applied, under rules made by the <sup>3</sup>[State Government] in this behalf, towards the grant of pensions or gratuities to members of the Police force of the town or suburbs of Calcutta.

Transfer and application of Calcutta and Suburban Police Superannuation Fund.
